- For all flights with Etihad Airways, there is Preclear US Immigration at Abu Dhabi airport. This is a process where all immigration, customs and agriculture inspections at Abu Dhabi International Airport uses the Middle East's only US Customs and Border facility. For guests from the US, Canada and those using the Visa Waiver Program, there are self-service Automated Passport Control kiosks. The benefit is shorter onward connections arriving in the US as a domestic passenger with all your entry formalities completed. - As a Certified Sandals Specialist, I visited the 22-acres resort in Barbados last month to learn details of the ground and the grand opening of Sandals Royal Barbados next door. Barbados's close proximity to other Caribbean islands particularly St. Lucia, Antigua and Barbuda gives a common misconception that Barbados itself is also in the hurricane belt. Fortunately, it is not. The last hurricane to visit Barbados was in 1955.
- Sandals is the world's only 5-star luxury all-inclusive resorts. Every Sandals resort in the Caribbean sits directly on a stunning beach. Sandals in Barbados offer a combined 16 restaurants, 11 bars, 5 pools and 2 spas. For an escape like no other experience the Caribbean's first rooftop pool and restaurant and complimentary airport transfers in a chauffeured Rolls-Royce, step from the bedroom to an infinity-edge plunge pool for a swim or float away in the largest river pool in the Caribbean. ### In the News!

- Starting Jan 22, 2018, TSA will enforce the Federally mandated REAL ID requirements on all domestic travel. For US states that have not been granted an extension, travelers 18 and over are required to present a passport, or other REAL ID compliant forms of identification before boarding a federally regulated commercial aircraft. The ID that is issued in the state and not of the state or country traveling to.
- TSA however confirmed on December 28, 2017 that the requirements above have now been postponed until October 11, 2018. Driver License or ID issued by the following nine states will remain valid for air travel until next fall: Kentucky, Maine, Minnesota, Missouri, Montana, Oklahoma, Pennsylvania, South Carolina, and Washington.

- There have been questions in the differences between TSA Precheck and Global Entry.
  - <u>TSA Precheck</u>
    - A government-sponsored program that allows approved passengers on domestic and some international flights access to expedited screening for flights departing from U.S. airports.
    - At a cost of \$85 membership for 5 years, wait time in line for security can be less than five minutes. PreCheck passengers don't need to remove your shoes, laptops, liquids,

belts and light jackets.

- <u>Global Entry</u>
- A U.S. Customs and Border Protection program that provides TSA PreCheck benefit plus expedited custom clearance to pre-approved travelers when entering the United States.
- Performance on similar background checks and in-person interview as with TSA Precheck. The cost is \$100 non-refundable fee for a five year membership.
- TSA is considering merging PreCheck and Global Entry programs in an effort to have better integration and a possibility for security enhancement with facial recognition. The two trusted traveler programs have similar costs, benefits and application procedures that could be confusing for travelers. The single program would eliminate frustration and duplication of effort at the airport.
- Is there a faster way to go through custom clearing if you don't have Global Entry? Yes! It is an app called <u>Mobile Passport Control</u> that is downloadable on smart phones. Passport information is completed and saved within the app including your own password for secured access. In place of an immigration paper that must be filled prior to custom clearing, you can now do it electronically. A QR scan will be sent to your phone within a few minutes of completing the form. Present this information on the phone along with your passport to the Immigration officer. Passengers having Mobile Passport Control will be in the same line with Global Entry, Military and Diplomats. The app currently only works for within the US and Canada.
- Any positive news with airlines? Yes! One of the changes airlines are making to have travel more affordable to the public is first-class airfare. Domestic First Class fare with Delta could be as little as \$50 more than a coach ticket or \$29 more on American Airlines. The values are in priority check-in, complimentary checked baggage, priority boarding, a more comfortable seat and lunch included! Online Travel Agents (OTAs) such as Kayak, Orbitz or Expedia does not have option to see difference in cost for the upgrade. You would have to check for it manually or work with a travel agent.
- On a different note, Department of Transportation announced last month that US airlines and ticketing agencies are no longer required to disclose baggage fees. Information about optional service fees such as checked bags is required to be available to the public on the website but not when passengers are buying tickets online, in person or over the phone. Be sure to check before you go to avoid any surprises in fees.
